SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Get medical advice/attention if you feel unwell or are concerned.

Eye Contact

Skin Contact

Rinse/wash with lukewarm, gently flowing water and mild soap for 5 minutes or until product is removed. If skin irritation occurs or you feel unwell: Get medical help.

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Large Fire: Dry chemical, CO2, alcohol resistant foam or water spray Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Chemical

Dense smoke may be generated while burning.

Precautions for Firefighters

Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Water spray is recommended to cool or protect exposed materials or structures. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Water spray may be useful in minimizing or dispersing vapors and to protect personnel. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

Emergency Procedure

SECTION 7) HANDLING AND STORAGE

General

Skin Protection

Use of gloves approved to relevant standards made from the following materials may provide suitable chemical protection: PVC, neoprene or nitrile rubber gloves. Always seek advice from glove suppliers. Contaminated gloves should be replaced. Use of an apron and over-boots of chemically impervious materials such as neoprene or nitrile rubber.

Respiratory protection
